The proposals from shareholders will be included in the agenda of the Meeting only if comply with requirements on the Article 23 paragraph (6) of the Article of Association of the Company and Article 12 paragraphs (1), (2), (3) and (4) POJK. The proposals shall be received by the Board of Directors no later than Tuesday, September 19<sup>th</sup>, 2017, at 16.30 WIB, 7 (seven) days prior to the date of the Meeting notice.
